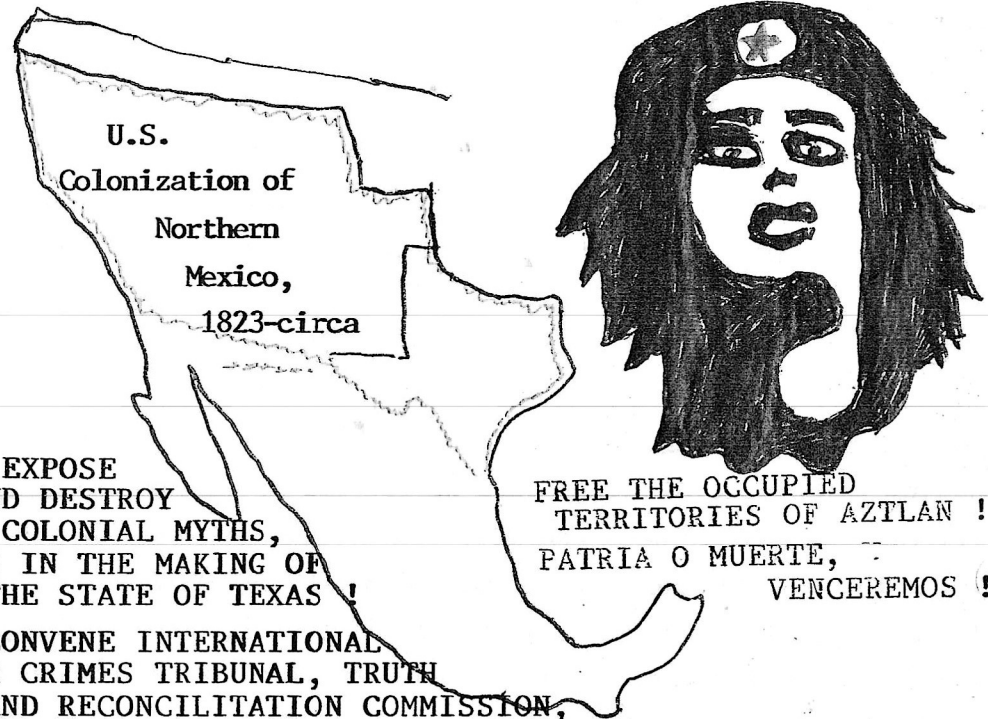

2023 will mark 200 years of one of the most horrific HOLOCAUST OF THE AMERICAS, to be, sadly, celebrated by many, commemorating the founding of the infamous TEXAS RANGERS, a militia in the making of Texas, known as LOS DIABLOS TEJANOS, or THE TEJANO DEVILS, as bloodthirsty hires of lawless white supremacy. Mexicans were hauled off in chains before defacto "judges" in mock kangaroo courts, such as the fraudulent LAW WEST OF THE PECOS SALOON COURT SET UP BY LAND HUNGRY USURPERS to strip Mexicans of all social, human rights, criminalizing them as "bandits" declaring them "personas non-grata" as ethnic cleansing swept Texas, in Mexican's own native homeland, and the birth of THE REPUBLIC OF TEXAS, an illegitimate gov't to this point in history. Thus, began a series of myths, lies and falsehoods, in keeping with the known dialectics of such a historical process of colonialism, through monstrous crimes, war crimes, lynchings, massacres, genocide, violent forced assimilation, of a white supremacy patriarchal slavery empire. This genocide was spearheaded by the notorious TEXAS RANGERS founded in 1823 by the father of white settler colonialism, STEPHEN F. AUSTIN, while confederacy statutes in honor of these WAR CRIMINAL were erected at many State Universities. Many books, films, and other neo-Nazi propaganda was produced, to justify this ugly history, a history buried in lies, CRITICAL RACE THEORY seeks the truth be told, but TEXAS continues to forever live IN SHAME AND INFAMY. These GESTAPO THUGS are today glorified in historical monuments

as heroes, patriots, such as in the TEXAS RANGERS MUSEUM in WACO, TEXAS, perpetuating these historical lies. Efforts to correct such injustices and to seek reparations for those savagely butchered by such a racist, evil system, have gone suppressed, such as the official hearings led by STATE REP. J.T. CANALES in 1918. Texas State Gov't has always responded to such efforts by suppression and enacting "laws" making it illegal to ever abolish the TEXAS RANGERS, aimed at keeping this bloody, ugly stain as the mantle of Texas. Truthful books are banned and new authors, scholars are black-listed, University professors threatened with termination and denied tenure if they teach CRITICAL RACE THEORY./ "Law" and racist arbitrary police powers have always been used as instruments of tyranny, paraded as patriotic acts. In the last 200 years, the TEXAS RANGERS continue to act in contemporary society as enforcers of colonial rule, working to destroy Mexicano-Chicano civil rights, anti-war movement organizations; break-up third political-party movements; the United Farm Workers union, labor movements; using young Chicanos as cannon fodder to fight imperialist wars in Southeast Asia; wringing out false confessions from suspects using police brutality and tricks, or covering-up police murders of young, innocent Chicanos, and concealing gov't abuses, injustices, in keeping up with modern-day neo-colonial criminal structures of domination, class rule, outlawed by international human rights laws, standards of evolving civilized societies. The enemies of true democracy have always intervened to keep Mexicanos-Chicanos oppressed.
