JR: No, I never saw Bill Cosby in prison. He was at a different facility. I did see Jerry Sandusky when he was at SCI Benner Two. for court. He was being held in administrative custody so nobody really gets to talk to him.

Steve: I'm in prison for selling drugs. I got a 10-20 year sentence but managed to get it reduced to 8-16 on appeal. I was selling heroin and cocaine. Drug distribution is a pretty common offense for people in prison. Andrew: No, Pennsylvania does not offer prisoners conjugal visits. I'm not really sure that any state offers that enymore. Does anybody know if that's still a thing? Sarah: I'm not really sure what you mean when you ask if prison is like on television. I'd say that its not because there is a lot of sitting in the cells doing nothing and they really don't show that on television. On TV they make it seem like prisoners are always out and around running around doing interesting things and that's not really accurate.






# Finally, a couple of statistics:

That's a lot of people & a lot of money.




