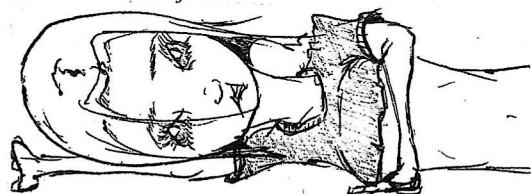

Scumbag Informant of the Month

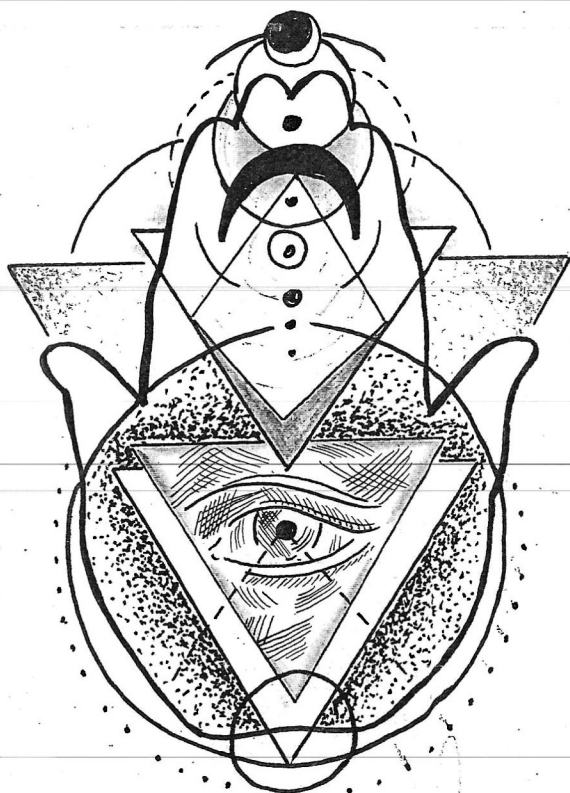

Snug Jim Peck's TCM Movie Review

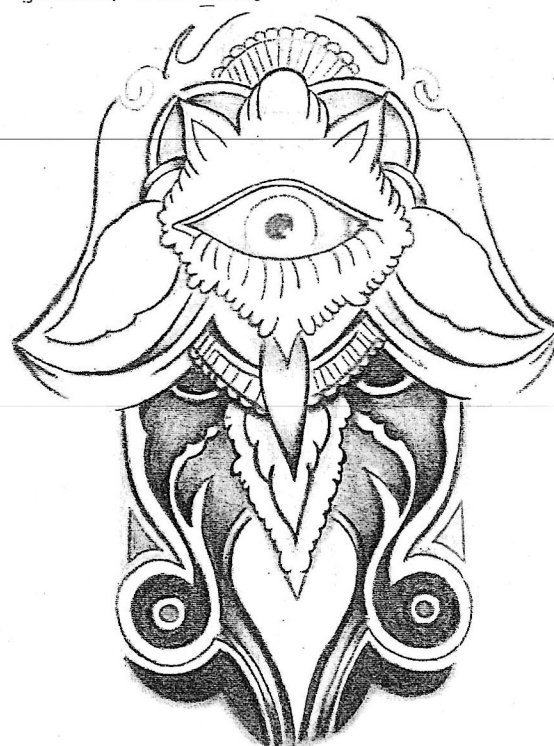

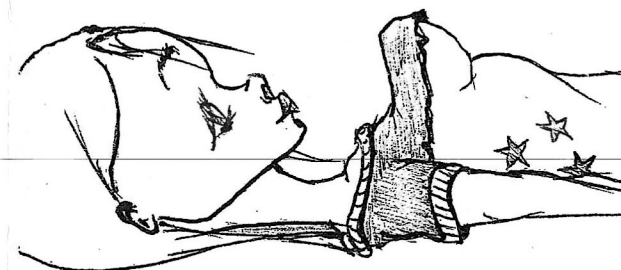


Legal Update

Picarella v. Wetzel, et al. No. 1:20-cv-1440 (M.D. Pa.)

There was a ruling on the Rule 12(h) motion to dismiss for failure to state a claim... It didn't go our way. The Court ruled that we couldn't sue Department officials in their official capacities because its the same as suing the state, which is prohibited by the 11th Amendment. We all know that. But the Court failed to notice that we also are seeking injunctive relief, which is allowed by the exception in Ex parte Young. Not sure how the Court missed that. Also, the Court ruled that we had no claim relating to the Pa.C.S. §5901 violations. We stipulated that §5901 violations aren't a Federal claims, but denying somebody a right afforded by state law certainly is a equal protection claim under the 14th Amendment! Again, not sure how the Court missed that...

No worries, we've got a motion for reconsideration pending so this may just get corrected without appeal.

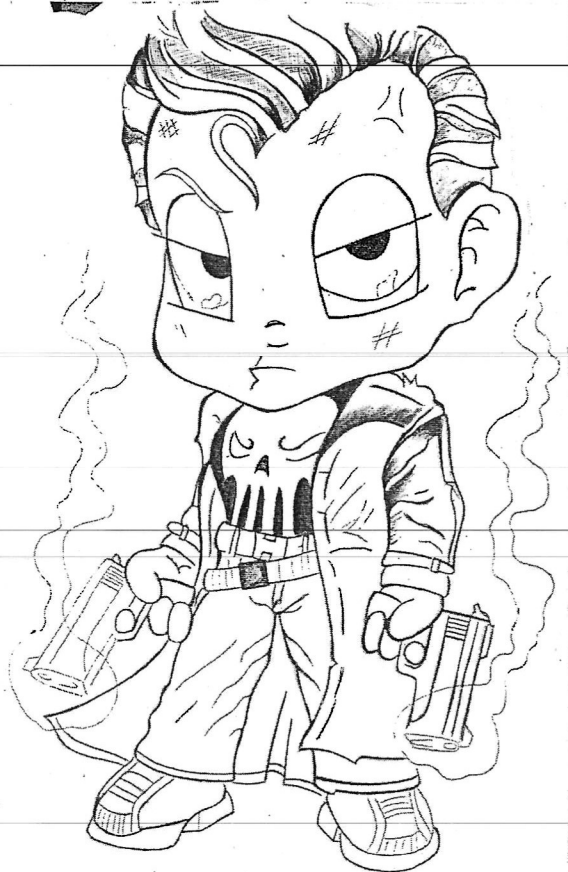

Prison Reform

One of our artist, Mike Corrado, went to Restricted Housing for violation of prison regulations. Mike was brewing some wine, which is a Class 1 misconduct.

Its important to understand what Restricted Housing is all about. Basically, a prisoner is locked into a cell that is about 15'x10' in size, generally without their property for the first week or so, and permitted out only five times a week for one hour of outdoor exercise in a 15'x15' fenced in concrete paddock. Restricted housing prisoners receive three showers a week. After about a week, they receive their property, which is limited to mostly books and paperwork. Prisoners are sentenced to Restricted housing for periods of 30 days to years.

People outside of prison may wonder what the big deal is about this. I propose the RHU challenge. Go empty out your bathroom, then drag a 3"x6" mattress in there, and try to spend a weekend in there. After a few hours, most people start to get frustrated and upset. Now imagine spending two months like that. Do you really think that is going to help anybody to become a better person? Is this really the best way that prisons have come up with to help instill "discipline"? As always, people wonder why they should care. Its simple, those people that are suffering in RHUs aren't always going to be in prison. Statistically, about 83% of prisoners will be released from incarceration in the future. That guy that is sitting in an RHU today might just be the guy the guy that moves in with your neighbor once he gets paroled. What kind of neighbor would you like, one that just spent the last 3 months locked in a bathroom-sized room with very little stimulation?

Again, I ask that you readers get interested and get involved. If you happen to run into a candidate running for a state level political office, ask them for their ideas on prison reform. If they don't have any, maybe they aren't the best candidate for the job...
