
Please be advised that it is my understanding that the enclosed roster is now posted at prisoner support websites.

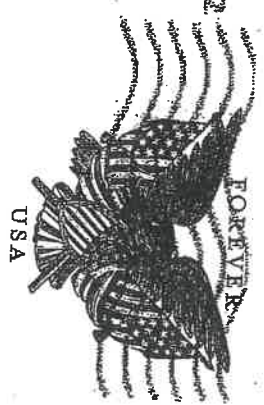

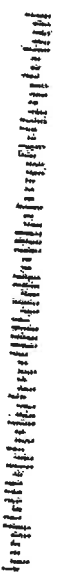
