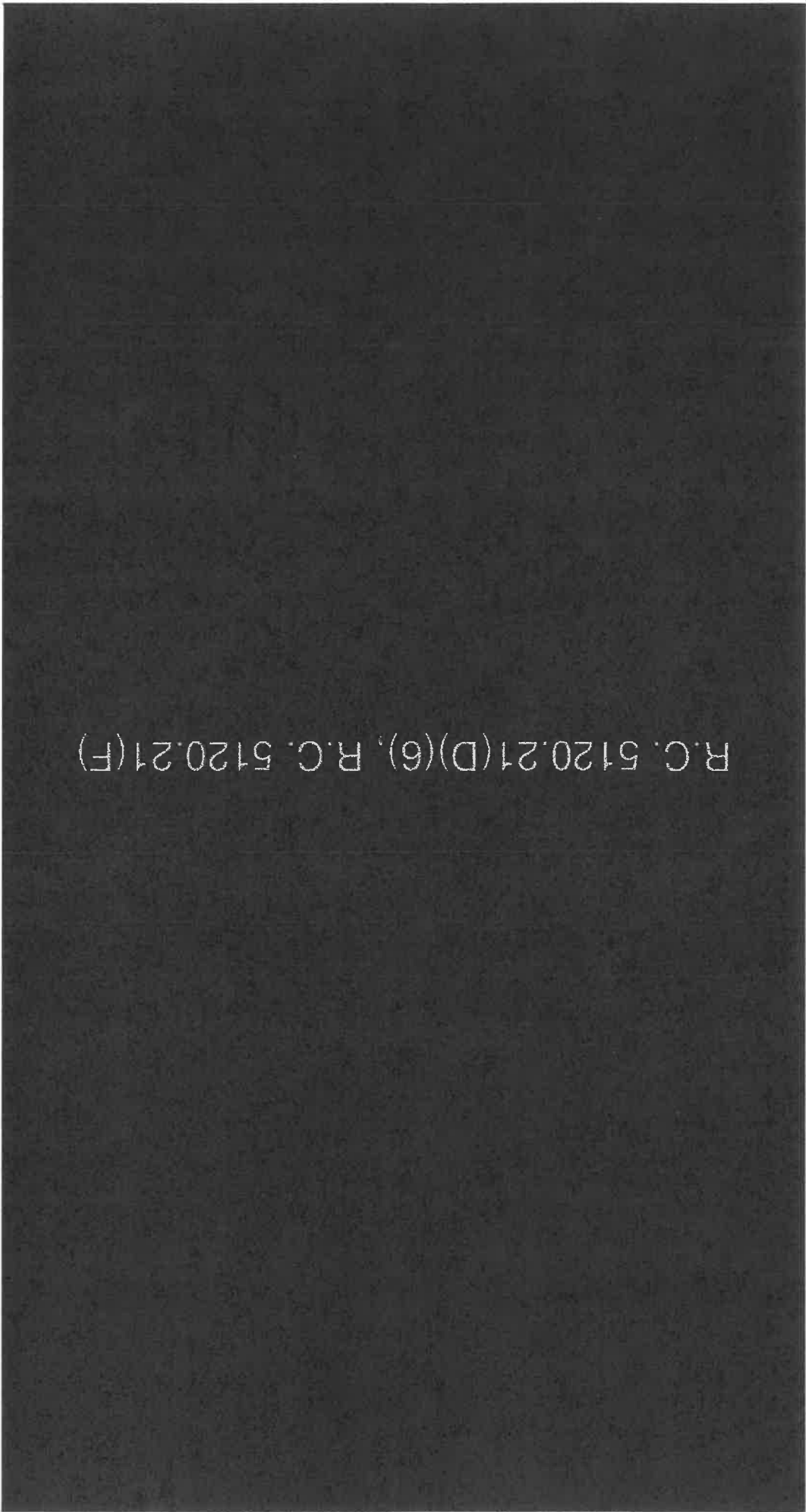

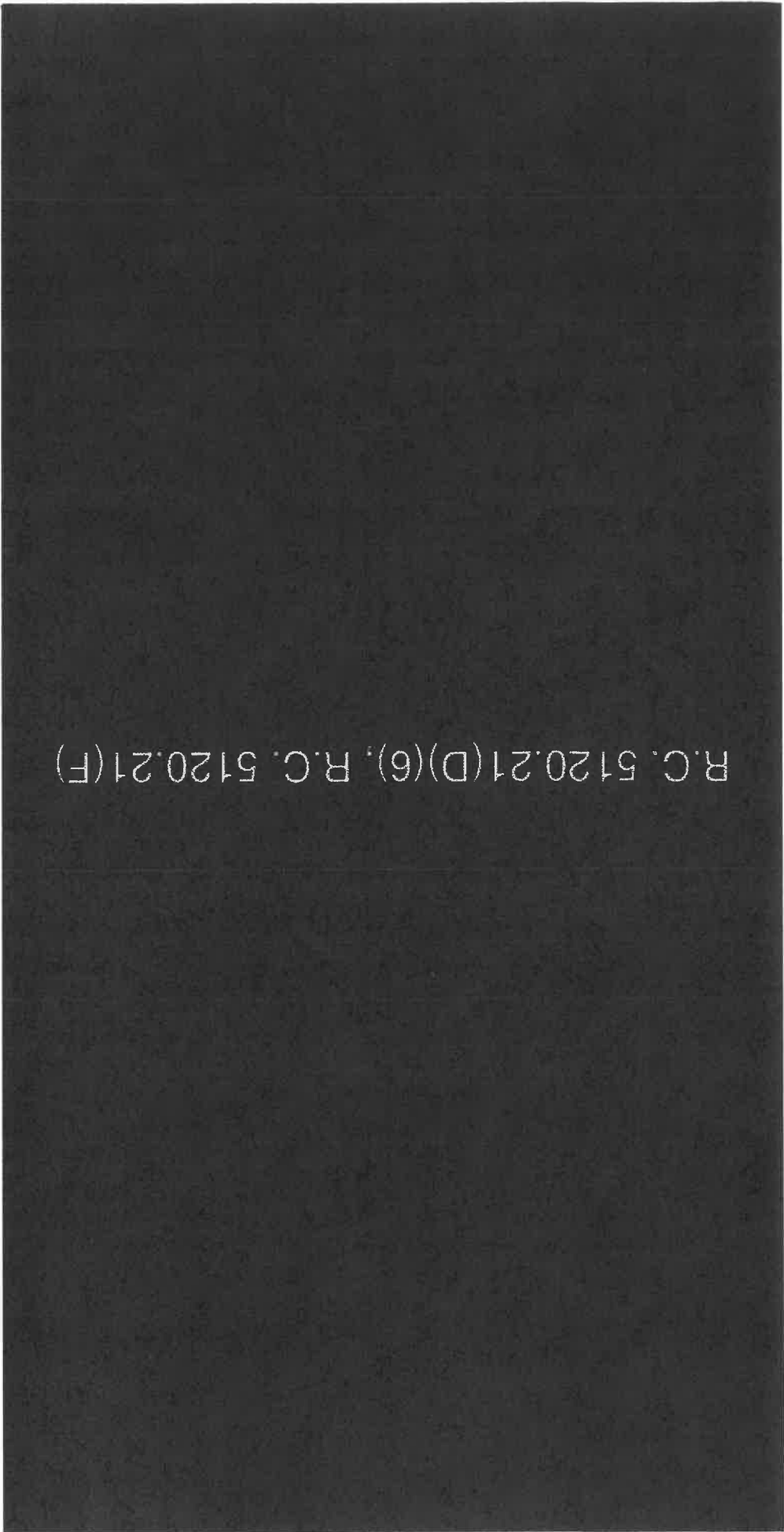

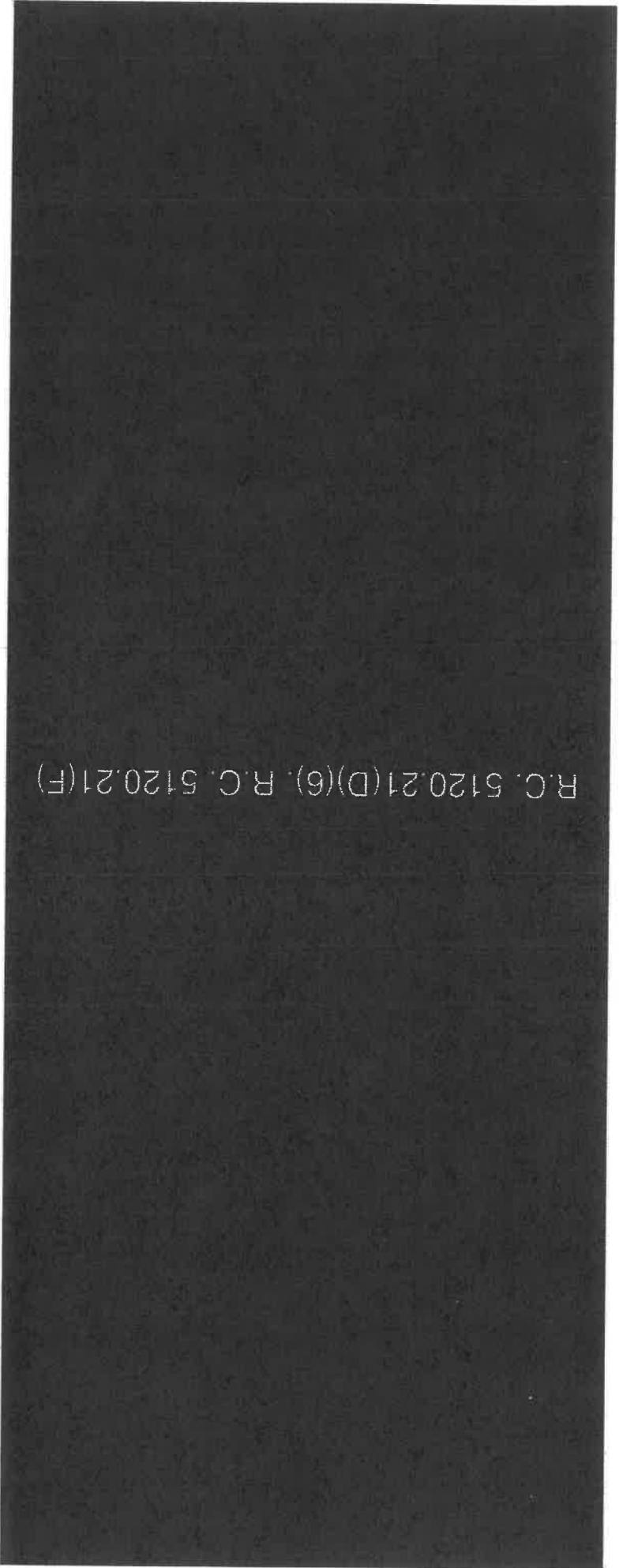

### A Revolutionary Salute,

This morning, it was something after 9:00, I was called out of my cell and told that somebody in the cage wanted to see me. I had no knowledge of who it was and the officers who was bringing me out had no knowledge who it was.

When I went out to the cage a few minutes afterwards, someone from the Ohio State Highway Patrol came to see me. He introduced himself as Mike Royko, he spelled it R-O-Y-K-O. He said that he had cases here from Youngstown, Trumbull Correctional Institution, as well as Ashabula County.

He wanted to know my name, what I was in prison for, and I told him, you know, "Cut the game. I mean that's not why you came out here. I'm sure you did all that investigation before you came out here to see me." Then

he went on to say that he heard that I was supposed to be involved in some kind of national militant movement to blow up buildings, to harm people, and I said, "Somebody must be sending you on a wild goose chase, because there's no such thing that's actually happened."

If it's coming from a prisoner, usually prisoners find themselves in a maximum security or supermax prison and they want to get out and they provide fictitious information to the prison authorities as a way to receive some type of leniency. When I'm telling 'ya all this information, if he or some of his people, or some people who like him, or others in prison in general, found out that I did this they are going to try to harm me and that's the game some prisoners play.

If it came not from a prisoner, I can't really speculate as to why that's going on. But I clearly explained to him that, you know, I am involved in various movements, because that was one of the questions he posed to me—I am I involved in any various movements or groups? I said, yes, I'm involved in Black Lives Matter, the Free Ohio Movement, and various different movements. People call on me to speak on radio programs and speak on college campuses about the quality of injustice that goes on behind enemy lines—police abuse, mass shootings, the killing of unarmed Black men, the list goes on and on and on. And that was the nature of our communication.

But before then he asked me the question, could he record what I'm saying. I said, "You do whatever you want to do. Because if you want to know what I'm saying, you can actually listen to my phone calls or read my mail." It's easy to read my mail. All you've got to do—the Warden can get permission from central office to open my mail and there's nothing illegal about doing that. With regard to my phone calls, actually all phone calls in the State of Ohio are being recorded. And the only ones that are not being recorded is someone who is fortunate enough to have a cell phone in their possession. I don't have that luxury so anything I say is actually on the phone.

But basically, what I tried to explain to them, which is truth, is that I'm involved in no radical movement that—not to my knowledge, unless someone is involved in some radicalism that I'm not aware—that I speak for myself or, if I speak, I'm speaking from a group base and everything that I'm involved in is peaceful movement trying to bring about revolutionary changes, and trying to bring about better conditions for prisoners, and trying to bring about emancipation and freedom from the case that I was erroneously convicted of, as a result of the Lucasville Uprising.

So that was the extend of our conversation, because I didn't want to have no long conversation. I just told him, continue to listen to my phone calls, continue to read my mail, and exactly what I'm telling you, if you come to find out something otherwise, then you can come back and you can throw it in my face. Otherwise not, and we have nothing else further to talk about really. And that conversation happened about nine something this morning.



Below is a link to the "Diary of Actions" of demonstrations, marches, or other acts across the country kept by the organization, Prisoner Resistance.

WCI inmate Swain A243205 is possibly participating and attempting to organize inmates in support of the September 9th Work Stoppage. Swain has been calling an unidentified male (234-201-0544) who records the phone calls and broadcasts. The unidentified male requested Swain make a recording to be broadcast at an event he is holding on August 22 in support of the September 9th strike. I have no identified that broadcast currently, but I will continue to watch for that call. However, Swain did record a call to be broadcast on September 4th, that he claims he cannot publicly state he supports the September 9th strike because he will be thrown in the hole by the FBI like (redacted). Swain continues to say he cannot tell the public how to give their support because he will be thrown in the hole and "all prisons have parking lots attached where workers cars are located-I'm not going to talk about coffee cans full of nails dumped at the entrances or keying cars in the warden's spots...or leaving junker cars at the entrances with the tires slashed or the parking break broken off and the doors locked." He also speaks about cyber and communication attacks "are out" since he will go to the hole if someone commits the act and he said he sent out lists of the ODRC fax numbers for people to fax black papers to ODRC fax machines to run out the cartridges. Swain mentions drones and having dance parties on prison officials sidewalks of their home but says he can't advocate such actions since he will go to the hole. I will continue to monitor Swain.

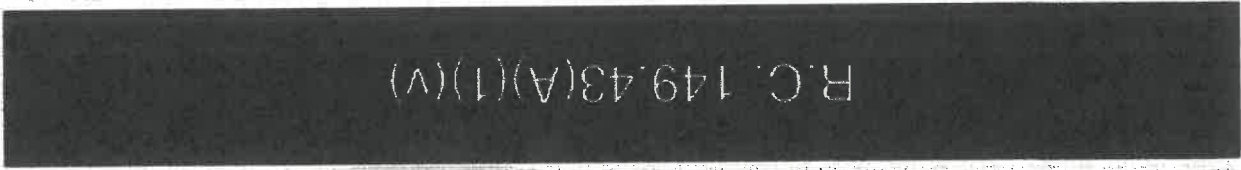

- The Anarchist Black Cross is a global anarchist prisoner support organization. Their West Coast chapters are actively organizing protests in support of September 9<sup>th</sup>. In May, a Columbus chapter was created called the Arawak City Chapter and along with the Indiana chapter, are supporting the protest this weekend. The Arawak chapter does not appear to have a lot of support as the Indiana chapter appears to have more participation in the organization of this weekend's protest.
- McGee claims that to date, over 100 people will be attending the August 27 protest. Facebook "reservations" are at 120 people and there are currently small groups intending to carpool from Kentucky and Indiana. McGee has links to Ben Turk and appears to be linked to the organizers and might have more knowledge of reservations on the Midwest Convergent website.
- Inmate Swain A243205 is scheduled to be broadcast during the Midwest Convergence Conference at some point when he is able to call in on August 27, 2016 between 14:30-15:30. Swain has organized the call in with Stephanie McGee, a possible member of the Anarchist Black Cross, Indiana Chapter. Inmate Swain claims to have sent McGee a statement about September 9<sup>th</sup> to possibly be read at the protest on August 27.

As a follow up to your below email, I sent you and Roger the information about the radio show and recordings last week as well as I spoke to Tony Lee about the Swain broadcastings. According to Tony, Swain is supposed to be limited to calling only his parents and girlfriend, however, he has been calling I believe Ben Turk since May. He has recorded broadcasts up through September 4 which Swain indirectly mentions flying drones into the prison, throwing nails in the employee parking lot, and several other violent acts. In addition Swain was able to call into the protesters prior to the march this past weekend.

How would you like me to proceed with this case as it is confirmed to be recording broadcasts for the radio which are being broadcast throughout multiple states. I listened to the broadcast last Thursday to determine if they are inflammatory but it's just bad music with "guests" that include Swain and even had Sanders a few months ago. I attached the email I sent since I been sending a lot of emails leading up to this weekend's protest.

Got your 8sep letter, great to hear from you. Based on what you said, you ought to win in the Oh SCT. I got denied on a habeas here in Warren County and just filed the appeal to the Oh SCT. My habeas was to challenge my conviction and sentence as void, and twelfth district deliberately re-constructed my issues as errors to raise on direct appeal and then procedurally barred me. If I don't win in Oh SCT, I think I have a good shot in federal habeas.

My old scamming grounds. Let me know if these folks are still there: Lt. Dabily used to be the RIB Chair. Angela Hunsinger was the investigator. It's my understanding that their home addresses are now posted all over the internet with tasteful photos of their homes and googlesnap applications so people can find the quickest routes for getting there. These fuckwasseals tortured me for a year. From there, I went to the super-duper-max, then to SOCF, and now to here. I'm booked here until at least July 2018 due to the bogus shit they keep stacking in my conduct file.

September, when I didn't try to take the prison away from prison officials on the anniversary of the Attica uprising, they confiscated a script from my radio segments and wrote a conduct report for contraband, using the term "terrorist" to describe what I was advocating in a segment that is regulated by the FCC. Ridiculous. And they do this right before I see the parole board. Pretty clear that their agenda is I see the parole board later this month. Hopefully, they'll have the sense to know they don't want 5 or 10 more years of this conflict. If not, they'll be getting 5 or 10 more years of this conflict.

Here at the prison, there have been several days of unauthorized vehicles zooming around the perimeter and driving the security vehicles bonkers. We were on lockdown all morning as they scrambled to catch somebody probing the perimeter. Looks like this is going to be a pattern. In my run for president, it appears that I'm guaranteed huge majorities in 20 states. Hackers have compromised the voting databases in 20 different states, and I fully anticipate that they will alter the vote tally in my favor. If Trump and Clinton split the other 30 states, I win.

I'm like a molotov cocktail tossed at the federal government. I'm promising to abolish the United States if elected. I know, ridiculous. But it's really fun. Hope things are good on your end. That's not a bad spot to do time so long as you're not on their radar. If you're on their radar, it kinda sucks. Let me know what's up.

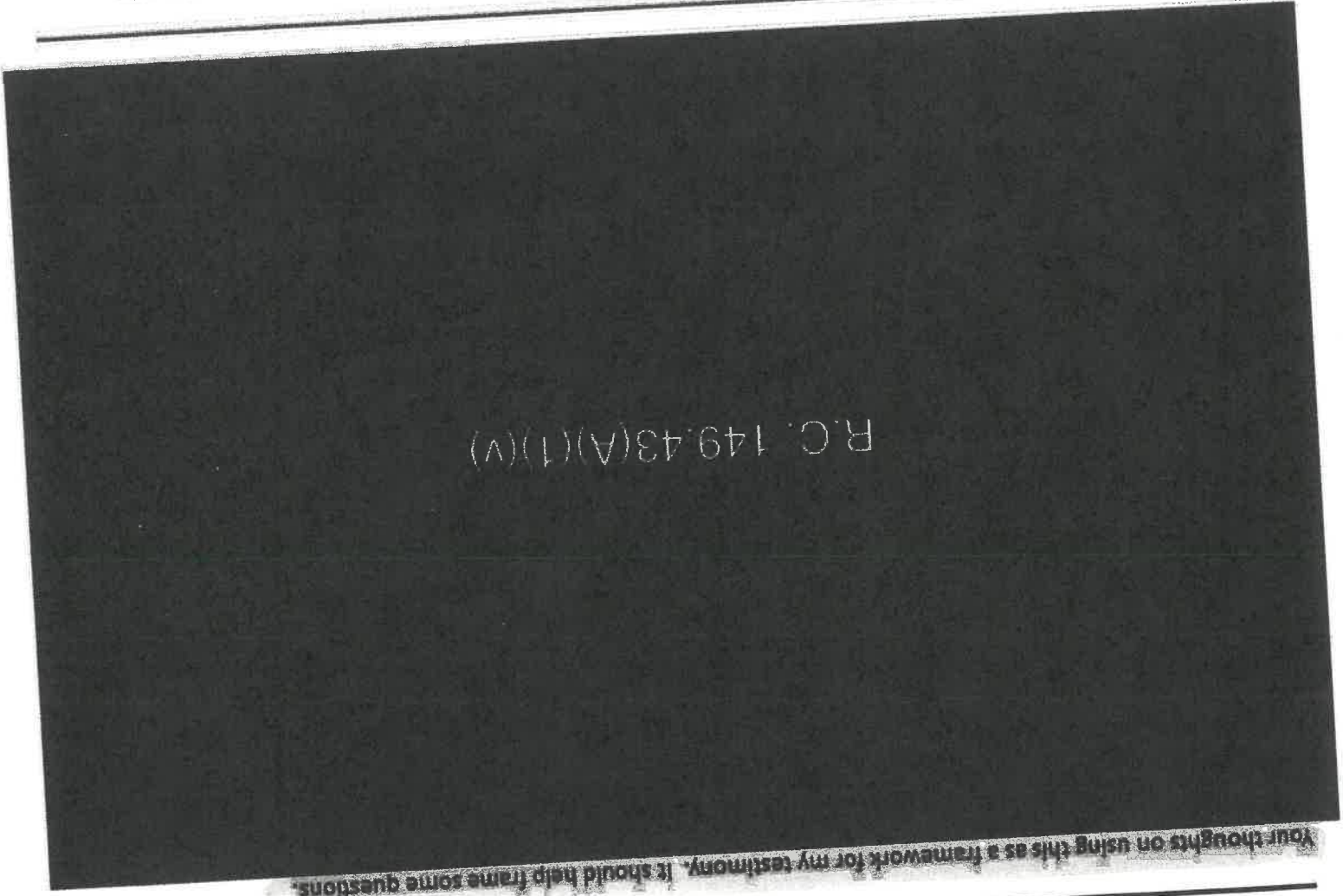
