I have spoken with Beverly Garner, [REDACTED] She and I have been playing phone tag since last Thursday. She addressed [REDACTED] had relayed some concerns to her and she wanted to make sure we are aware. She states his unit is down 2 phones and one of the phones that does work shocks you when you use it. Her second concern was that there is an inmate in [REDACTED] unit who is allegedly urinating and defecating on himself. She states the washer/dryer had been down in the unit for over 3 days and this caused health violations with the inmate having such issues. And, third, she addressed the mail room is not being consistent. She states she calls them before she sends anything and wanted to send him a calendar. She states she was given the clearance to do so but when it was sent, it was returned to her and she was told it wasn't allowed. She also addressed that other inmates are getting pornographic pictures through the mail and she doesn't understand how a calendar gets blocked but nude pictures do not. I told her I would let you know of her concerns. Thanks!

B. Routine Data for Release

1. Upon request from a news media representative, the following information about an inmate, parolee, probationer, or other releasee shall be made available:

- a. Name and inmate number;
 - b. Age and date of birth;
 - c. Race, gender, and available physical description;
 - d. County where crime was committed;
 - e. Crime and sentence;
 - f. Admission date;
 - g. Sentencing entry;
 - h. Prison transfers (dates and locations only);
 - i. Outside court actions regarding confinement and release, where known;
 - j. RIB actions (RIB dispositions only);
 - k. Institutional work assignments;
 - l. Security level
 - m. Prior DRC incarceration(s);
 - n. Release eligibility and supervision history (date and type only);
 - o. Time at Large (absconded or escaped);
 - p. Death (The identity of a deceased inmate shall be withheld until next-of-kin have been notified or 24 hours following death, whichever occurs first). The cause of death shall not be released until made official.
2. Information regarding psychiatric, medical or juvenile criminal histories of DRC inmates cannot be released under law.

3. Inmate photos can be accessed by the DRC internet site. If the photo is not available on the internet, the Office of Communications or institution PIO can provide the photo given there is not a threat to security.
4. Release of certain information concerning staff is a matter of public record. This includes photographs if available. Where possible, the involved staff shall be notified when inquiries are made.
5. Other information shall be released to the news media at the discretion of the Director or designee.

Dear Mr. Swain:

Please be advised that we have decided to permit reinstatement of your J-Pay account. Warren Correctional Institution (WCI) will be authorized to allow you access to your account and video visits/videograms in accordance with institutional rules and regulations. WCI will also be authorized to restrict your access for violations of the inmate rules of conduct for defined periods as set forth in 5120-9-07 and 5120-9-08 of the Ohio Administrative Code.

We encourage you to use J-Pay to communicate with friends and family through email, videograms and video visits. Be advised that use of your J-Pay account to record video for media, websites or other improper purposes will result in a permanent revocation of your J-Pay privileges. Also note that further attempts to harass or intimidate staff members will also result in a permanent revocation of these reinstated privileges. These terms are not negotiable.

We will issue the order to J-Pay to remove the restriction; however, please note that it may take several business days for the action to be completed.

1. This complaint originates from Defendant's destruction of Plaintiff's property valued at \$25,000 contrary to Defendant's duty of reasonable care.

2. Plaintiff Sean Swain is a prisoner held at Warren Correctional Institution ("WCI") in Lebanon, Ohio. Plaintiff has, for more than two years, maintained a weekly segment on the Final Straw radio show, broadcast out of Asheville, North Carolina. This radio show is then syndicated globally and re-broadcast by radio stations all over the world, to include Belgium, France, Australia, New Zealand, Canada, and across the United States. Beyond the syndicated broadcasts, the radio show is then uploaded to websites for free access by so-called "pirate" radio. Finally, Plaintiff's radio segments are then uploaded to I-Tunes where the segments may be purchased and downloaded individually.

3. Plaintiff has been ideologically targeted and subjected to torture by the Ohio Department of Rehabilitation and Correction for speaking out. Plaintiff continues to speak out.

4. In November 2016, Plaintiff worked at the WCI library as a law clerk. Plaintiff worked for the WCI Librarian, Harry Burchell. Plaintiff's duties included the preparation of the WCI law

library pass list as well as consultation with other prisoners in assisting and preparing their legal work, to include their criminal appeals, lawsuits against the State, and matters such as divorces and child custody/child support. Plaintiff had worked in the law library since September 2015, shortly after his arrival at WCI and maintained nearly two hundred files of prisoners he had assisted in that time.

5. On November 17, 2016, Plaintiff took a document to his supervisor, Mr. Burchell, for copying. The document related to Plaintiff's appearance before the Ohio Adult Parole Authority, for which Plaintiff had a civil action pending in the Tenth District Court of Appeals. See, *Swain v. Ohio Adult Parole Authority*, Tenth Dist. Court of Appeals Case No. 16AP000519.

6. At WCI there exists a complicated process for prisoners to obtain legal copies. A prisoner must first submit a withdrawal for the full amount of the cost of the copies, calculated at five cents per page. Once the prison cashier processes that request and returns a copy of the request through internal mail to the librarian, the prisoner then may present the pages for copying along with the proper requisition form. The librarian then takes up to forty-eight hours, by policy, to make the copies. However, depending upon what day of the week that the copies are requested in relation to the days that the library is scheduled to be closed, a prisoner may wait an additional six days for the copies. As a consequence, it has taken up to twelve days for a prisoner to obtain copies of legal documents.

7. In this case, Plaintiff already had funds withdrawn in advance and needed only for the librarian to make the copies.

8. On November 17, 2016, Mr. Burchell did not make the copies. On November 18, 2016, Plaintiff asked Mr. Burchell whether the copies had been completed. Mr. Burchell indicated that they had not, and told Plaintiff that he had "read" the content of pages three and

four of the document and that the content "troubled" him; as a consequence, Mr. Burchell had sent e-mails to other administrators inquiring as to what he (Mr. Burchell) should do with the document Plaintiff sought to have copied.¹

9. Plaintiff spoke with Mr. Burchell again on November 19, 2016, but the copies had not been made and Mr. Burchell indicated that no one had answered his e-mails to direct him as to what he should do. The library was closed on November 20 and 21, 2016, and when it re-opened on November 22, 2016, Plaintiff quit his job at the law library.

10. Plaintiff waited until December 3, 2016, before he employed the internal grievance process, providing WCI ample time to make a determination about his documents and make the copies.

11. In her Disposition of Grievance dated December 19, 2016, acting Institutional Inspector Jennifer M. Smith wrote that Plaintiff's copies were not made and that the original documents that Plaintiff turned in to Mr. Burchell were "destroyed." The acting Inspector indicated that this action was taken due to the allegation that "threatening statements" to "state officials" were contained in the documents.

12. As point of fact, Plaintiff did not make any threatening statements in documents turned over to Mr. Burchell for copies. Plaintiff has not so much as been accused of "threats" which would violate the Inmate Rules of Conduct and would warrant a conduct report if the accusation is true. Further, "threats" would be a criminal act prohibited by statute. Yet, Plaintiff has not been charged with any criminal conduct.

¹ As point of fact, appropriately, Mr. Burchell should not have been "reading" the document in the first place. As the acting Institutional Inspector Jennifer M. Smith pointed out in her Disposition of Grievance on this matter, Mr. Burchell had only a responsibility to "look through the documents for contraband," not to read the document. Given that Mr. Burchell found "troubling" content on both page three and page four, which were back-to-back on the same piece of paper, it is clear that Mr. Burchell was doing more than "looking through" the document.

13. Absent even an accusation of misconduct, Plaintiff's legal documents related to his appearance before the Ohio Adult Parole Authority could not be designated as "contraband" as there would exist no basis for such a designation. Thus, *de facto*, Plaintiff's legal documents were legal documents.²

14. At no time did Plaintiff consent to the destruction of his legal documents that he turned over to Mr. Burchell for copying.

15. On December 2, 2016, Plaintiff received via mail an offer by a third party to purchase the "originals" of the documents that Plaintiff had turned in for copying, as the third party sought to sell the originals on e-Bay. The third party offered Plaintiff \$25,000 for those documents.

16. Plaintiff is now unable to transmit his documents to the third party, as the ODRC has destroyed them without Plaintiff's consent.

WHEREFORE, Plaintiff prays for damages in the amount of \$25,000 to compensate Plaintiff for losses as a consequence of Defendant's failure to perform its duty of care. Plaintiff additionally requests \$50,000 for great pain of mind and body. Plaintiff also requests a DECLARATION that Defendant's actions violated the rights of Plaintiff, and Plaintiff finally requests all other relief from this Court this is just and equitable.

² Even accepting the justification provided by Inspector Smith as true—which Plaintiff does not—the documents would constitute evidence of criminal conduct and their destruction would constitute Tampering with Evidence and Obstruction of Justice. So, even by Inspector Smith's narrative of events, there would be no rational reason to destroy Plaintiff's legal documents.
