These emails communicated threats towards staff and family members of the Ohio Department of Rehabilitation and Correction. A few comments stated that "if you torture us we'll light your cars and houses on fire" and "let cans of gasoline be your verbs, and matches be your nouns." The attached three (3) JPay emails are deemed by the Chief Inspector's Office as a direct threat to all ODRC staff. End of report.....
