Attached is the report on the information we have obtained thus far on the August 19 protest. There has been no discussion of disruption within the institutions by prisoners, but there will be a protest held in Columbus organized by the Free Ohio Movement. Vanessa Sparks of the Free Ohio Movement expects the turnout to be small, but [REDACTED] has contacted a Black Panthers member to organize a security detail of which they may be possibly armed. It appears there is a massive divide between the anarchists/IWOC, the Free Ohio Movement, and other groups in contact with [REDACTED].

Additionally, inmate [REDACTED] will likely begin a hunger strike on Thursday in protest of the cancellation of religious services. Ben Turk will be possibly arranging a calling campaign against Todd Ishee.

Also, I have monitored inmate Swain, but he has not discussed August 19 thus far and appears to be focused on his 2018 campaign for governor.

There has been no discussion of disruption within the institutions by prisoners, but there will be a protest held in Columbus organized by the Free Ohio Movement. Vanessa Sparks of the Free Ohio Movement expects the turnout to be small, but [REDACTED] has contacted a Black Panthers member to organize a security detail of which they may be possibly armed. It appears there is a massive divide between the anarchists/IWOC, the Free Ohio Movement, and other groups in contact with [REDACTED].

Additionally, inmate [REDACTED] will likely begin a hunger strike on Thursday in protest of the cancellation of religious services. Ben Turk will be possibly arranging a calling campaign against Todd Ishee.

Also, I have monitored inmate Swain, but he has not discussed August 19 thus far and appears to be focused on his 2018 campaign for governor.

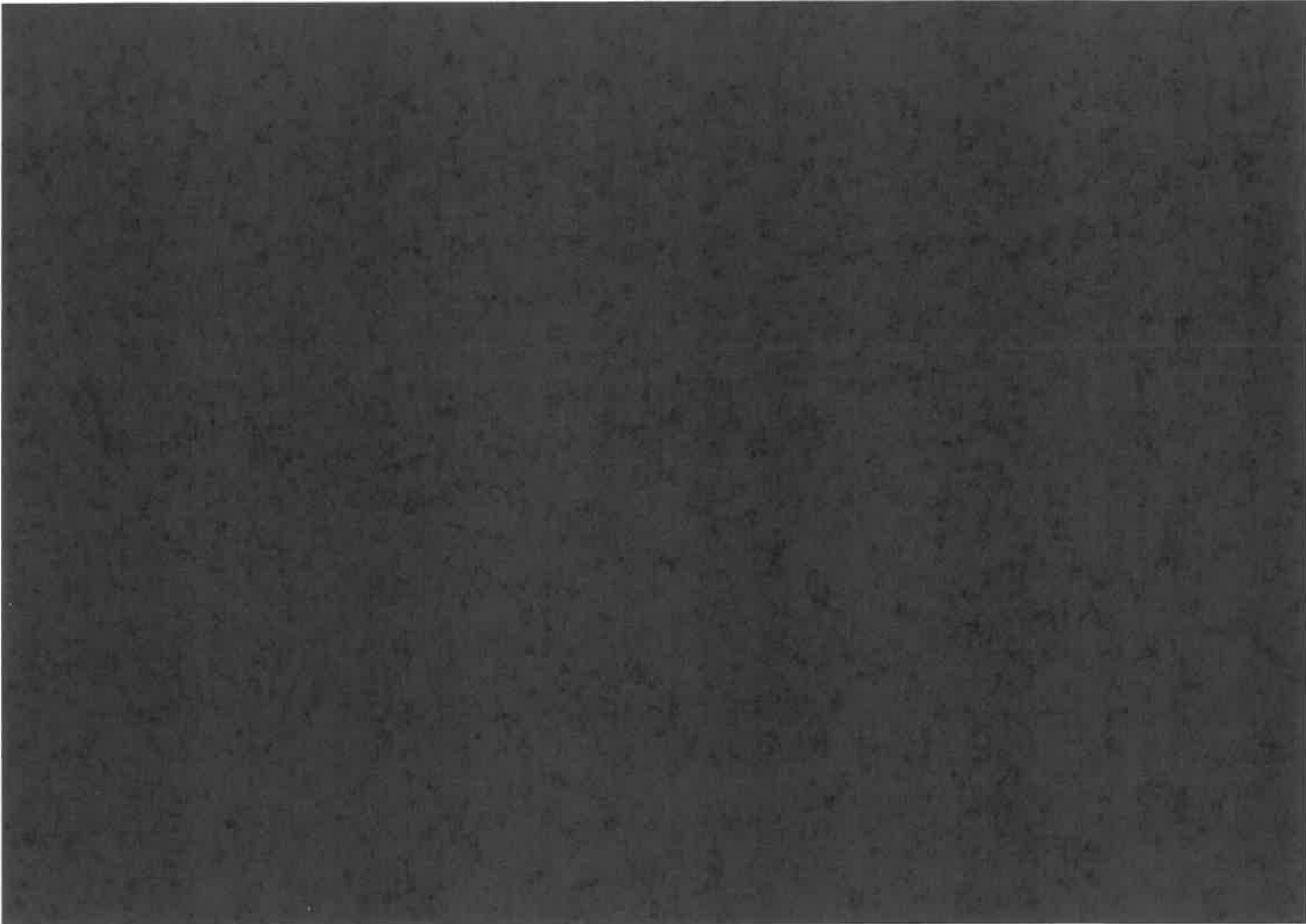
